Ryan Nichols		On May 10, 2026 Nichols was arrested after allegedly displaying a firearm during a dispute in a church parking lot, according to the Harrison County Sheriff's Office.
Edward Jacob Lang	#GasMaskBatman	Feb 2026 , first-degree damage to property, committing a bias crime
Ryan Yates	#Insider731	May 2026 , Arrested as part of the human trafficking and prostitution sting operation called "Polk Around & Find Out,"
Landon Kenneth Copeland	#RedPoloRising	On February 5, 2021 , about one month after the Capitol riot, the defendant was stopped while driving and cited for speeding, driving on a suspended or revoked license, displaying the wrong plate, and for failure to provide proof of insurance. While the defendant was stopped, he became argumentative with law enforcement and claimed that he was being harassed. He was asked to step out of the vehicle and ordered to hand over his keys, but he refused, turned the vehicle on, and tried to roll up the driver's side window. Ultimately, the officer was able to arrest the defendant after shattering the window and ordering him out of the vehicle at gunpoint. During this traffic stop, the police officer observed a rifle with ammunition May 25, 2025 , arrested on charges of felony breaking or entering, felony theft of property (firearm valued less than \$2,500), felony possession of a firearm by certain persons, and felony aggravated assault. Oct 2025 first-degree terroristic threatening. Copeland threatened to go to the electric company's office and shoot "everybody in it."
Andrew Kyle Grigsby	#FlagBuffNS	two counts of possessing or viewing of matter portraying a sexual performance by a minor
Josiah Mark Kenyon	#PinStripeBoilerSuit	Dec 2021 Kenyon was arrested on the federal charges, along with his wife, Elizabeth, for child endangerment. Deputies reportedly found an AR-15 rifle, a Glock handgun, ammunition and other weaponry inside the camouflaged car.
James Tate Grant	#YoungSkullMan	December 7, 2021 , Grant was charged in Wake County, North Carolina, with driving while impaired. According to the police report, at approximately 5:00 a.m., an officer from the Garner Police Department responded to a restaurant in response to a suicide threat. While pulling into the parking lot, the officer observed the Defendant pulling out in a silver car. The Defendant put his hands out of the window and attempted to get the officer's attention. The officer approached the Defendant, who stated, "They probably called on me," and further explained his involvement in the "January 6th incident." Because the Defendant appeared intoxicated, the officer initiated a DWI investigation. While being placed under arrest, Grant attempted to flee. He then dropped to the ground and stated something to the effect of "Just kill me now." He then stated, "It's over." In Grant's car, officers recovered an AR-15 assault rifle, 60 rounds of .223 ammunition, weapon accessories, and combat fatigues. The Defendant was arrested and transported to a local medical center. He was charged with Driving While Impaired, and his case remains pending in Wake County District Court.
William Wright Watson	#Insider1526	On Jan. 5, 2021, when Watson traveled to Washington, D.C, Watson was on pretrial release for the Alabama drug trafficking charged, and the conditions of his pretrial release forbade him from leaving the state. On January 11, 2021 , following Watson's return to Alabama, a writ of arrest was issued in relation to the violation of his bond conditions committed by traveling out of state without authorization on Jan. 5, 2021. Watson's bond was revoked and he was committed to pretrial detention.

Jonathan Munafo	#BoylnTheHood	In April 2021 , Munafo was arrested for the federal criminal case out of the WDMI. Munafo pleaded guilty to a felony violation of making Interstate Threatening Communications. Munafo has completed the imposed 24-month sentence of incarceration and will commence serving the three-year term of supervised release once he is released on this case. On January 5, 2021—Calhoun County, Michigan—While at a rest stop in Dunns, North Carolina, and over a three-hour time period, Munafo made approximately 143 threatening calls to 911 dispatchers in Calhoun County, Michigan. Munafo claimed that his name was “Yankee Patriot” and told a dispatcher that he was going to cut her throat. Munafo cited to the dispatcher accurate information regarding her home address and mortgage payment arrangements. Munafo’s behavior and repeated calls also tied up the entire county emergency response system. A few of Munafo’s quotes include: “Put a fucking cop on the phone now you stupid bitch, or it’s going to go way worse for your family!” “Bitch, I’m gonna cut your throat. I’m gonna make you eat your fucking nose. I’m gonna hurt you bad for this. It won’t be today, it won’t be tomorrow, it’ll be fucking soon though, you stupid cunt. Insurrection Act, I’m coming to your door first and it’s public knowledge, you stupid, stupid bitch!” May 2021 and while in the custody of the Federal Bureau of Prisons, Munafo was charged with a Prisoner Placing a Bodily Fluid on a Government Employee. This case was later dismissed.
Dillion Colby Herrington	#MagaLogThrower	Dec 2023 indicted by a Limestone County grand jury on a charge of first-degree rape According to court documents, Herrington “did engage in sexual intercourse with (victim name redacted), a member of the opposite sex, who was incapable of consent by reason of being physically helpless or mentally incapacitated.”
Cody Page Carter Connell		On December 14, 2022 , Connell pled guilty to simple criminal damage to property and was sentenced to a deferred sentence of three months of incarceration and six months of probation. Connell was arrested at his home in Bossier City, Louisiana on May 12, 2023 . The officer who arrested Mr. Connell listed a charge of 2nd degree battery.
Leonard Anthony Lobianco	#OrangeLensesPB	Feb 8, 2022 charges unknown Sarasota, Florida
Kim Sorgente		March 13, 2021 charged with two counts of assault with a deadly weapon related to the Dec. 6 protest at 17th and Bristol streets in Santa Ana
Alan Michael St Onge	#HawaiianMorningNews	Dec 2023 on pretrial release, he was arrested for allegedly throwing an ashtray at a woman and then punching her in the throat at a bar. When another bar patron intervened, St. Onge allegedly pushed him to the ground, kicked him, and stomped on his chest. Id. St. Onge then fled the scene in his car and was arrested for driving under the influence of alcohol.
Daniel Charles Ball	#FlashBangMan	April 27, 2021 , BALL was arrested near his home in Florida by the Citrus County Sheriff’s Office for the battery (assaulting) of five civilians and two law enforcement officers unrelated to his actions on January 6, 2021. Following his conviction for two counts of battery on a law enforcement officer, BALL was sentenced to serve five years of probation. May 2023 Ball illegally possessed a firearm and ammunition despite being a convicted felon with three prior convictions between 2017 and 2021.
Casey Jane Tyron-Castro	#HatHag	August 17, 2024 , and charged with one count of public intoxication and two counts of assault on law enforcement. Id. According to Roanoke Police Department reports, officers responded to Dr. Pepper Park on August 17, 2024 after receiving a report of trespassing. Upon arrival, officers were advised that Tryon-Castro had snuck into a concert and refused to leave. When officers approached Tryon-Castro, they noticed she was “unsteady on her feet” and had the odor of alcohol on her breath. Id. at 2. Officers asked her name several times and Tryon-Castro eventually yelled back “none of your fucking business.” An officer then attempted to detain her, but she resisted and attempted to run away. Officers restrained her and placed her under arrest. She was then transported to the Roanoke City Jail. According to the criminal complaint filed in the General District Court for Roanoke City, after Tryon-Castro arrived at the jail, correctional officers attempted to change Tryon-Castro’s clothes. Tryon-Castro then became assaultive and attempted to bite one of the deputies on the leg. Tryon-Castro then aggressively kicked another officer multiple times on her right knee, shoulder, and chin. Accused committed the offense (s) charged,” namely two charges of assault and battery of an officer (a felony) and one charge of public intoxication (a misdemeanor)

Shane Jason Woods	#AllBlackTrumpHat	On November 8, 2022 , while he was released and awaiting sentencing, a Divernon police officer stopped Woods in Sangamon County, Illinois, and detected alcohol on his breath. After Woods made statements about attempting suicide, he fled the traffic stop, drove the wrong way through an exit ramp onto I-55, and drove northbound in the southbound lanes, causing a multi-vehicle crash. His pickup truck crashed into a car driven by 35-year-old Lauren Wegner from Clayton, North Carolina. Wegner died from multiple blunt force injuries, according to the coroner's office of the county. Woods was arrested for reckless homicide, aggravated driving under the influence, driving under the influence, and fleeing/eluding police.
Timothy Desjardins	#flatcapattacker	Desjardin was convicted in connection with a September 2021 shooting in the parking lot of a Walgreens store on Atwells Avenue in Providence. Prosecutors said it stemmed from a dispute between Desjardins and another driver. Nov 30, 2021 , Desjardins was involved in an armed standoff with police from inside his barbershop on Federal Hill. <i>Sentenced to 38 years, with 18 to serve. He won't be eligible for parole for 20 years.</i>
Thomas Harlen Smith	#MississippiFlagGuy	Mar 24, 2021 , Smith was arrested after he was indicted for embezzlement. A \$657.20 demand letter was presented to Smith when he was arrested. Smith is accused of embezzling fuel by siphoning it out of a county-owned truck. Smith purportedly hid fuel containers on the side of the road so he could stop and siphon fuel from the truck into the containers. Smith would allegedly return to the location in a personal vehicle to retrieve the fuel he had siphoned. Investigators determined this scheme lasted from June 2019 to August 2019. Smith was arrested in November 2021 and convicted of Contributing to the Delinquency of a Minor in May 2022. Smith was originally charged with Child Abuse without Bodily Harm, and the disturbing details are recounted in the PSR
Emily Hernandez		On Jan 5, 2022 , Victoria Wilson was riding northbound on I-44 in a car with her husband, Ryan Wilson, as the pair drove toward their home in St. Clair. They were returning from Sullivan, where they had gone to celebrate their 15th wedding anniversary. As the couple drove north, Emily Hernandez hit their vehicle on the front passenger side. Victoria "Vickie" Wilson was killed in the crash and Ryan Wilson was seriously injured. Hernandez has been charged with two counts of driving while intoxicated. A preliminary breath test indicated that her blood alcohol content was .2 percent, which is more than twice the legal limit to drive in Missouri.
Andrew Taake	#MacerInBlack	In May 2016, Taake was arrested for soliciting a minor online, a felony. According to the PSR, Taake initiated a conversation on a social media application with an undercover officer ("UC") posing as a 15-year-old girl. After sending multiple explicit messages to the UC, Taake proposed an in-person meeting. The UC agreed and sent Taake an address. Before the meeting, Taake sent additional messages to the UC, including telling her that he "could go to jail" for what he was doing. Taake then went to the address the UC provided and was arrested. He was released on a \$20,000 bond. His bond was revoked after his arrest and detainment in this case. The case remains pending. ARRESTED 2/6/2025 for these charges While detained at USP – Lewisburg during the pendency and detention in this very case, Taake was found guilty of fighting with another inmate in March 2022 and August 2022 and of giving/accepting money without authorization in December 2022. While detained at the D.C. Jail, Taake was written up for fighting with another inmate on December 14, 2023, less than two weeks before his change-of-plea hearing. Though he claimed self-defense, jail officials reviewed the CCTV footage and issued him a disciplinary report.

Joshua Lee Atwood	#LeadPipeGuy	<p>In 2021, just one month after committing his criminal conduct on January 6, Atwood was arrested, plead guilty to, and was sentenced to fines and costs for disorderly conduct in Hanover, Pennsylvania. According to Hanover Township Police Department records, Atwood was involved in an altercation with an officer during a traffic accident investigation. The investigating officer noticed a strong smell of marijuana emanating from Atwood's vehicle, and Atwood claimed he did not know what marijuana smells like. Atwood proceeded to berate law enforcement as they attempted to relocate the involved vehicles and claimed officers were just "following orders like the Jews did when they entered concentration camps[.]" which prompted an argument between Atwood and a tow truck operator, who was Jewish. An officer was forced to break up the conflict. Police later secured a search warrant for the vehicle and discovered marijuana and a glass pipe. According to Chester Police Department records, on April 28, 2023, Atwood and a male victim working at a restaurant in Chester got into an argument. During the argument, Atwood grabbed a handful of cash bills out of the register, then attempted to leave with the money. When the victim attempted to stop Atwood, the two men got into a fight, during which Atwood dropped a concealed handgun. Atwood pulled out a concealed knife and stabbed the victim. Atwood then retrieved his dropped handgun and fled from the restaurant. In connection with the Chester incident, law enforcement checked Atwood's address on record, but it appeared that no one was residing at that address. It took law enforcement several weeks to ultimately locate Atwood at a different address, and the effort required the assistance of the U.S. Marshals Service Fugitive Task Force.</p>
John D. Andries	#TrifectaTraitor	<p>On February 25, 2022, Andries violated his conditions of release in this case when he was arrested for, inter alia, felony assault on a police officer. According to the police report, at approximately 11:37 pm on February 25, 2022, at Action Lounge & Billiards in Leonardtown, Maryland, Andries became intoxicated and reportedly pulled a female's hair and made "patrons uncomfortable." Andries was asked to leave the establishment. Andries became belligerent and made threats to staff who removed him from the premises. . Andries attempted to reenter the bar and was being held back by staff when police, who happened to be at the establishment for another incident, offered assistance to the staff in dealing with Andries. Police attempted to calm Andries and explain that if the staff wanted him removed, he needed to leave. Andries refused to comply with the police directives and attempted to reenter the bar. Police informed Andries to either go home or be arrested. Andries stated, "nope" and then pushed one of the officers in the chest, whereupon he was placed in handcuffs. Andries refused to cooperate with police, sat down while handcuffed, and had to be dragged and carried to a police vehicle. Once at the police vehicle, Andries refused to sit properly and laid so that his upper body was in the vehicle seat, but his lower body remained outside the vehicle. Id. Additional officers had to be summoned assist in bringing Andries under control. An officer told Andries that if he did not comply and sit in the vehicle, he would be tased. Andries refused to sit in the vehicle, whereupon the officer tased his leg. Undeterred, Andries still refused to sit in the vehicle and was tased a second time, but still did not enter the police vehicle. Officers determined they needed to call the jail's transport van to bring Andries to jail. While waiting for the van to arrive, Andries repeatedly kicked an officer and had to be restrained until the transport van arrived. He then refused to enter the van and had to be carried and placed inside by police. A search incident to lawful arrest found Andries was carrying a knife. According to court records, Andries was charged with felony assault in the second degree, misdemeanor disorderly conduct and misdemeanor resisting/interfering with arrest. In May 2022, Andries pled guilty to resisting arrest and was sentenced to 180 days jail, all suspended but 10 days, and two years unsupervised probation. On October 17, 2022, Andries was again arrested in Maryland on a charge of assault in the second degree for punching the complainant in the face. In that case, Andries's ex-girlfriend's new boyfriend claims Andries punched him in the face during a custody exchange of Andries's child. The charges remain pending, and a trial is scheduled for January 2023.</p>
Curtis Logan Tate	#ShinyCircleTattoo	<p>In July 2021, the defendant (age 30) was charged with driving with a suspended license and leaving the scene of an accident in Clark, Indiana. In that case, another vehicle struck Tate's vehicle and Tate drove away from the accident before police officers arrived at the scene.</p>
Michael Jerrett Amos	#Insider1689	<p>May 3, 2022 DUI Influence Drug or Alcohol, Property Damage, Apr 18, 2023 DUI</p>

Brandon Fellows		arrested in New York for petit larceny on April 29, 2021 , from an incident that spanned from December 28, 2020, through March 4, 2021. The complainant hired Fellows to complete a chimney repair, after they agreed to a price and timeframe. On December 28, 2020, Fellows performed an inspection and outlined the necessary work to be performed, and the complainant paid him a \$700 deposit. However, in the following weeks, Fellows did not arrive to perform the repair as scheduled, ignored the complainant's phone calls regarding the job, and blocked her number. On January 31, 2021, the complainant filed a police report. Fellows told the police that he had ordered the materials for the job and therefore did not intend to repay the complainant.
Andrew Paul Johnson	#Insider1732	Jun 3, 2022 resisting arrest, May 22, 2023 violation for arrest and charge for driving with a suspended license); (June 7, 2023 violation for unauthorized possession of a driver's license, resisting an officer, and driving under the influence); ECF No. 29 (July 14, 2023 violation for failure to report a law enforcement contact where Johnson was alleged to have attempted to commit retail theft but did not receive any ticket or citation) Aug 26, 2025 charges including lewd and lascivious molestation of children under 12 and between 12 and 16, lewd and lascivious exhibition, and transmitting harmful material to minors.
Dominic Box		August 2023 , Box had his license suspended in Jacksonville, Fla., earlier in the month when he refused to take a breathalyzer, an apparent violation of his bond conditions. But his lawyer said he could not attend the Washington hearing because he was in the Jacksonville jail, following a separate incident where a sheriff's deputy found him unconscious in his car in the parking lot of a barbecue restaurant.
Bryan Betancur	#Insider2160	March 2024 violating an anti-stalking order
Jarod Lee Hawks	#GrogBountyHunter	Aug 16, 2022 Burglary with a battery, felony battery, Dec 6, 2023 BATTERY –Resisting an officer without violence
Joseph Martin Pastucci	#CapitolCapCompanion	July 3, 2023, Pastucci was arraigned on charges of rape, aggravated indecent assault, sexual assault, indecent assault, stalking, and false imprisonment
Kene Brian Lazo	#Walistambo	Arrested on August 23, 2021 , on several charges, including contributing to the delinquency of a child under the age of 13; aggravated sexual battery of a child under 13; intercourse by force, threat or intimidation; forcible sodomy by force, threat, or of an incapacitated or physically helpless person over the age of 13; and two counts of simple assault.
Joshua Dillon Haynes	#HarleySmashAOM	On July 27, 2021 , Haynes was arrested in Covington, Virginia, and charged with state law offenses of strangulation, malicious wounding, destruction of property, and assault and battery
Daniel Herendeen		November 17, 2021 , he was arrested and charged with possession of less than 25 grams of a controlled substance
Narayana Chandra Rheiner	#LynyrSinner	In 2019, Rheiner was convicted of Attempted Second Degree Burglary. He was accepted into a drug court and received a sentence of five years of probation. In April 2021 , a bench warrant was issued, apparently as the result of a drug arrest noted under "Supervision Adjustment". That warrant was executed in July 2021, but another bench warrant was issued in August 2021. That warrant was executed in March 2022 , following Rheiner's arrest and release from custody in this case. In April 2022 , he was terminated from Drug Court upon a finding that Drug Court was not successful and sentenced to 3 years' incarceration, all suspended but 321 days, for which he was given credit. Rheiner's probation was subsequently revoked, and he served an additional term of incarceration of 263 days.
Daryl Eugene Johnson	#Insider447	Jan 27, 2023 : Charged with one count of invasion of privacy for the purpose of arousing or gratifying a sexual desire and one count of interference with official acts. Using his cell phone to surreptitiously record a woman as she was changing clothes at a tanning salon. "The defendant placed the phone on the edge of the wall so his camera was facing the adjacent room where a female was tanning," the affidavit states. "The female victim did not know they were being filmed and did not consent to be filmed while undressing, tanning, and redressing." Police indicated that the alleged secret recording of the woman may not be an isolated incident. Sentenced to six months in prison.
Luke Wessley Bender	#Insider244	Jan 26, 2021 DWI, Unresolved case in Stafford County, Virginia, arising from conduct on July 7, 2020. Bender allegedly stole a piece of heavy construction equipment and misused it for nearly 45 minutes, causing extensive damage to an excavator, track loader, and nearby items. He was arrested on November 28, 2022 , when forensic evidence tied him to the crimes. Bender has been charged with five offenses, including grand larceny and unauthorized use of a motor vehicle.

Brent John Holdridge		November 12, 2024 Possession of a Controlled Substance, Possession of Marijuana for sale, Possession of Marijuana, Receiving Stolen Property, May 11, 2025 arrested and booked into the Humboldt County Correctional Facility on charges of PC 459 (Burglary), PC 487(a) (Grand Theft), and PC 496(a) (Possession of Stolen Property).
Benjamin Heffelfinger	#Insider1542	On February 2, 2021 , Heffelfinger pled guilty to a November 2020 Illegal Use or Possession of Marihuana Drug Paraphernalia. He was sentenced to a \$100 fine. On January 5, 2022 , Heffelfinger pled guilty to Illegal Use or Possession of Drug Paraphernalia. He was sentenced to a \$50 fine. On August 10, 2023 , Heffelfinger pled guilty to Physical Control of a Vehicle While Under the Influence. He was sentenced to conditional probation for 1 year, participation in the Drivers Improvement Program in lieu of jail time, and 90 days on SCRAM, an alcohol monitoring device.
Mark Mazza		November 10, 2021 , conviction in Indiana. According to the police report on August 2, 2021 , the juvenile victim (a Hispanic boy aged 12) was attacked by Mazza after he and his friends (aged 11, 12 and 14) made derogatory comments about Donald Trump after seeing a large Trump flag hanging above Mazza's home. According to the report, Mazza responded to the victim and his friends that, Trump "kills n*s like you," which led to a verbal and physical altercation during which Mazza picked up the 12-year-old victim by the neck, slammed him on the ground and continued to hold him by the neck on the ground. The victim indicated he was unable to breathe for a period of the assault, which is not surprising given Mazza's size. The victim told officers when he was interviewed that he was still suffering pain on the back of his head. The report also indicates that Mazza told officers he got into the argument because the victim used the "N" word and he wanted them to stop. Mazza admitted to the police that he assaulted the juvenile and held him down by the neck on the ground.
David Paul Daniel	#ThirstyTrumper	September 20, 2024 Arrested in North Carolina for sexual exploitation of a minor and child pornography
Matthew Huttle	#Insider3080	Huttle has four other pending charges – all based on conduct that occurred after Jan 6, 2021
Landon Brady Manwaring	#Insider2727	On May 11, 2022 , Manwaring engaged in a sexually explicit online conversation with someone he believed to be a 13-year-old child but who was actually a state police officer pretending to be a child. According to the state charging document: The defendant told the child he would show her things like rubbing her clit and hitting her g-spot. The defendant then sent pictures of his penis and stated he would help her grab it and stroke it. He then sent a picture of his erect penis and asked [the child] if she would suck his penis. The defendant then agreed to meet up with the child. The underlying police report, which summarizes the chat records, reveals that it was Manwaring who continually pushed the sexually explicit conversation forward, asking the "child" questions like how old was the oldest boy she had ever kissed, if she had ever done more than kiss, if she masturbated, and if she would be willing to touch and suck his penis. When Manwaring arrived at the pre-arranged location, he was arrested by state law enforcement officers. He was originally charged with Enticing a Minor, in violation of Utah Crim. Code Ann. § 76-4- 401, as the top count but that charge was dismissed as a condition of Manwaring's plea agreement. On October 11, 2022 , the state court sentenced the defendant to five years of imprisonment, with all but 30 days suspended and credit for 10 days already served, followed by four years of probation, as well as a \$750 fine. The court ordered that the defendant complete his jail sentence by December 31, 2022
Tyler Bradley Dykes	#GrayGoose	Feb 2023 he was arrested for Unite the Right Rally: Burning an object in a public place with the intent to intimidate. Dykes pleaded guilty to a state felony charge and was sentenced to 5 years in prison, with 4 1/2 years suspended. The Unite the Right rally was a white supremacist rally that took place in Charlottesville, Virginia, in Aug 2017
Thomas Eugene Tatum		May 16, 2023 Arrested in Washington DC for assault
Edward Raymond Kelley		Found guilty in US District Court in Tennessee of 2022 charges conspiracy to murder federal employees, solicitation of violent crime and threatening a federal official, sentenced to life in prison

John George Todd III		On September 9, 2022 , Todd's ex-wife contacted Blue Springs Police Department advising the defendant was suicidal and armed with a gun. On April 24, 2023 , Todd was identified climbing up the side of a building with razor blades and knives on his person, attempting to enter the home of the man who was romantically involved with Todd's ex-wife. The officers at the scene found Todd intoxicated and found three 3-inch horizontal cuts on his Todd's inner forearm. Todd told police officers that he had been trying to kill himself and he was transported from the scene for a 96-hour mental health evaluation. There were police reports made for both incidents. The Magistrate Court found this episode concerning enough that it placed Todd into a high intensity supervision program and required him to move to a different state to be put in the care of his sister

Jia Liu	#Insider405	Liu was arrested in February 2022 in the Eastern District of New York (EDNY). He was charged with conspiracy to defraud the United States Department of Health & Human Services, conspiracy to defraud the United States Department of Defense, and conspiracy to forge government writings. Liu and another individual conspired to steal and forge genuine covid-19 vaccination cards. They forged the stolen cards to indicate that unvaccinated persons received the covid-19 vaccination. Liu and his co-conspirator distributed at least 200 false vaccination records and received thousands of dollars in exchange. As part of this scheme, Liu and his co-conspirator also created more than 70 false entries into immunization databases maintained by the New York State Department of Health. In May 2023 , Liu pled guilty to conspiracy to defraud the Department of Health and Human Services
Howard Richardson	#SwingerGramps	On September 23, 2021 , Richardson allegedly assaulted a motorcyclist riding down his street. The victim reported that Richardson "tackled him" off his motorcycle, causing a crash. The incident was witnessed by neighbors and captured on a surveillance camera located across the street from the event. The victim rider can be heard in the surveillance footage screaming out in pain. He was taken to the emergency room and treated for significant injuries including stitches to his eyebrow area, ligament damage to his fingers, and surgery for a "chunk taken out of his right leg." About five minutes later, the victim's brother came to assist, carrying a metal pipe or spike. He claimed Richardson "brandished a firearm" and so he dropped the pipe. A neighbor who witnessed the aftermath of the incident said he saw Richardson go to his truck, which was parked near the site of the crash, and pull out a knife with a 7-inch blade which he displayed to the brother. After the incident, Richardson spoke to the police; his account was significantly different from the victim's and the neighbor's. Richardson claimed he had been trying to slow down the motorcyclist and that the rider clipped him as he (Richardson) attempted to get out of the way. He also denied brandishing any weapon, including a firearm or a knife, during the incident. The video does not reflect any effort by Richardson to get out of the way; instead, he appears to lean into the rider's path. Richardson was charged with aggravated assault and other crimes relating to this incident. He was arrested on October 25, 2021 .
Marcos Panayiotou		On December 2, 2021 , during the execution of the warrant for Panayiotou's arrest and warrant for the search of his residence, law enforcement officers observed a H7K VP9 handgun on the nightstand next to Panayiotou's bed. The handgun had a high-capacity, seventeen round magazine containing fourteen rounds. Panayiotou was then charged with a violation of N.J.S.A. 2C:39-3J. Panayiotou was later convicted of Disorderly Conduct.
Matthew Webler		December 3, 2021 , Mr. Webler was charged by Criminal Complaint in the Northern District of Georgia with firearms violations based upon certain items located inside of his home at the time of his arrest.

As an agent grabbed his arm, the Adams swung his arm and struck one of the agents in the face with his elbow. Adams then continued to physically resist, retreated further into the home, and refused to comply with verbal commands. Four agents attempted to restrain Adams and place him in handcuffs, but he continued to resist. Once in handcuffs, the defendant continued making threatening remarks, such as “I will kick your ass.” Following a two-day jury trial in the District of Utah, Adams was acquitted of the charge.
